## **1.0 RCC Tests**

It looks like everyone has taken and passed the RCC test. Can you please email me a copy of your certificate for record purposes. If you have not already passed the test, you cannot legally fly at Warren Farm until you have done so.

## **2.0 Bob's Planes and Equipment**

Bob's planes and equipment were sold to Plane Olde Bargains (apart from the Angel S, which Malcolm bought). The proceeds were donated to Bob's widow, Anne.

POB were not interested in the rest of Bob's equipment (tools, materials, etc) which Bob had accumulated over the years. I took a lot of pictures of the equipment to show POB. ## **3.0 Flying Field**

## **4.0 Fees**

Some members have already paid BMFA fees directly to the BMFA. This has proved very straightforward to complete. The same applies for Operator ID. I therefore suggest all members pay BMFA directly for BMFA membership and the Operator ID.

The club subscription was due by the end of the year. Ideally, this should be paid by members directly into the WFRF account (Sort code 40-42-13, Account 71601733).

We will maintain the annual club membership fee at £40 for adults and £20 for juniors.

The two topics which affect us are copied in full below.

## **1 Remote ID**

“The issue of remote ID has caused some concern and confusion over recent months. It is important to note that none of the new requirements will come into effect for model aircraft until 2028 and as we reported previously, exemptions to these requirements will be granted for model flyers operating under the BMFA Article 16 Authorisation.

Whilst the exact details have yet to be finalised, we remain optimistic that there will be a good outcome for our members and that the impact of the new regulations on the activities carried out under the BMFA umbrella will continue to be minimal.

Currently only drones with a UK1, UK2 and UK3 class mark (currently we are not aware of any) must broadcast a Remote ID. All other drones and model aircraft are currently exempt.”
